

WAIVER OF CONFLICT

We, the City of Burien, Washington, the City of Des Moines, Washington, and the City of SeaTac, Washington, hereby acknowledge that we have carefully read the foregoing letter, informing us that our interests may potentially be in conflict with those of Vashon Island Fair Skies in connection with Leech Tishman Nelson Hardiman, Inc.'s representation of our interests and those of Vashon Island Fair Skies in connection with the Petition for Review of the FAA's Finding of No Significant Impact and Record of Decision for the Sustainable Airport Master Plan Near-Term Projects at the Seattle-Tacoma International Airport ("SAMP").

We expressly acknowledge that the concurrent representation by Leech Tishman Nelson Hardiman, Inc. of our interests and those of Vashon Island Fair Skies constitutes the representation of potentially conflicting interests, to the extent that our interests and those of Vashon Island Fair Skies are potentially adverse. We nevertheless knowingly and voluntarily consent to such concurrent representation by Leech Tishman Nelson Hardiman, Inc. Further, we knowingly and voluntarily consent to the payment of legal fees to Leech Tishman Nelson Hardiman, Inc. by a person or entity other than ourselves.

We further expressly acknowledge that we have been advised that we have the right to seek independent legal counsel in connection with the advisability of waiving said conflict, and that we have had a reasonable opportunity to do so.
