1. CALL TO ORDER

3. APPROVE MINUTES

The minutes for the September 21, 2021 Burien Airport Committee (BAC) meeting were approved.

4. BUSINESS AGENDA

a) Review of Burien's 2022 Legislative Priorities.

Mike Doubleday, Federal Relations, provided an update on the 1st draft of Burien's 2022 Federal Legislative Priorities related to Reducing Airport Noise and Emissions. The priorities include support for bills sponsored by Congressman Adam Smith including HR 6038 (Aviation Impacted Communities Act) and HR 4068 (Protecting Airport Communities from Particle Emissions Act). Other priorities include support of noise metrics review of whether 65 decibels (dB) is the appropriate level, and mitigation efforts, such as noise insulation programs.

RECOMMENDATION: The Committee recommends to the Burien City Council to send a letter of support for HR 6038 and HR 4068, for potential discussion at their October 25, 2021 Study Session.

FOLLOW-UP: Mike Doubleday will check status of the federal noise policy review of the 65 dB level, and if appropriate, the Committee recommends to the Burien City Council to send a support letter.

b) Appointment of Deputy Mayor Krystal Marx to King County’s Joint Aircraft Emissions Technical and Community Task Force.

It was suggested that Deputy Mayor Marx be invited to a Burien Airport Committee meeting in early 2022 to provide an update on the Task Force.

c) Update of StART (SEA Stakeholder Advisory Round Table) activities.

City Manager Wilson provided an update on the last StART meeting held on August 25, 2021. The Sustainable Airport Master Plan (SAMP) has been delayed until 1st quarter 2022 and the comment period has been extended from 30 to 60 days. Other updates included the Federal Policy Working Group, Sustainable Skies Act, Aviation Noise Working Group, and some airlines changing to quieter planes. Burien’s two StART community representatives are Jeff Harbaugh and Diana Smith.

d) Future Items for November 16th BAC meeting:

- Presentation by City staff on Boulevard Park and Ambaum Corridor Community Plans.
- Presentation from Port of Seattle on the noise insulation program, status of program, and specific areas that qualify.
