### 1. CALL TO ORDER

Chair Schilling called the Burien Airport Committee meeting to order at 6:00 p.m.

It was noted that Councilmember Jimmy Matta and Committee Members Savannah Sly and Stephen Wydick arrived late.

### 3. APPROVE MINUTES

a) Minutes of the March 15, 2022, Burien Airport Committee Meeting.

It was moved by Committee Member Karen Veloria, seconded by Committee Member Jeff Harbaugh, to approve the minutes of the March 15, 2022, Burien Airport Committee meeting. Motion passed unanimously.

### 4. BUSINESS AGENDA

a) **Burien Airport Committee Vice-Chair**: Chair Schilling led a discussion to receive nominations for Vice Chair of the Burien Airport Committee.

It was moved by Mayor Sofia Aragon, seconded by Councilmember Jimmy Matta, to nominate and elect Committee Member Karen Veloria as Vice Chair of the Burien Airport Committee. Motion passed unanimously.

- b) StART (SEA Stakeholder Advisory Round Table) Activities: Interim Ex-Officio Newsom, provided a report on the StART Aviation Noise Working Group. Committee discussion ensued.
- c) **Open Position of the Burien Airport Committee**: Chair Schilling led a brief discussion regarding the open position of the Burien Airport Committee. No action was taken.
- d) **Burien Airport Committee Draft Workplan**: Mayor Sofia Aragon led the Committee in a discussion regarding the draft work plan.

It was noted that Vice Chair Veloria was interested in assisting with health mitigation efforts, and Committee Member Savannah Sly shared interest in working on Burien's Climate Action Plan.

Mayor Aragon requested a general presentation of Burien's Climate Action Plan at the next Burien Airport Committee meeting.

It was moved by Mayor Sofia Aragon, seconded by Councilmember Jimmy Matta, to direct staff to draft a letter to the Port, requesting that the Port request the FAA to allow a 60-day review of the SAMP; to have the Burien Airport Committee review the draft letter, then recommend to Council for approval. Motion passed unanimously.

e) **Federal Legislative Updates**: Mayor Sofia Aragon provided a brief report that she, Deputy Mayor Schilling, and Councilmember Garcia attended the National League of Cities Conference. It was noted that discussion occurred with members of congress regarding health impacts/concerns in airport communities.

### 5. PUBLIC COMMENT

 Dave Kaplan, Port of Seattle, shared that in addition to what City Attorney Newsom reported regarding the StART Committee Meeting, Alaska Airlines shared an announcement of the elimination of their Q400 aircraft, which may address the concern expressed relative to the planes turning over Burien and not just the noise of the aircraft themselves. When the elimination of the aircraft occurs, it should help reduce/eliminate planes turning over Burien.

### Dear Director Lyttle:

During a 2022 StART meeting, Federal Aviation Administration (FAA) representative Justin Biassou reminded Port of Seattle (Port) representative Ms. Arlyn Purcell that the Port must make a written request to the FAA if the Port or a municipality wants more than 45 days to review the Sustainable Airport Master Plan (SAMP).

Due to the anticipated length and technical nature of the SAMP, the City of Burien respectfully asks that the Port of Seattle submit a written request to the FAA to grant a substantially longer review period of the SAMP. Since, in addition to being lengthy and detailed, the SAMP will govern not only the Port's short-term goals but the Port's long-term vision, it would be difficult for Burien (or any municipality) to carefully review and share thoughtful feedback on the SAMP in less than 60 days. In fact, having only 45-60 days to review the SAMP would make it difficult to review the SAMP and then seek council guidance on any response or recommendations. Permitting 90 to 120 days for municipal review would be more helpful.

This request is consistent with the Port's SAMP priorities stated on its SAMP webpage. The Port's SAMP webpage states that the Port wants to "minimize impacts to our neighbors" and have community engagement as the SAMP develops. The best way to achieve both goals is to allow your neighbors and the surrounding communities enough time to evaluate operations and impacts and respond to the SAMP.

Finally, please request a substantially longer review period soon to avoid a response from the FAA that the request was late.
