1. CALL TO ORDER

The meeting was called to order at 6:10 p.m.

2. APPROVE DRAFT MINUTES

The minutes from the June 18, 2019 Burien Airport Committee meeting were approved.

3. BUSINESS AGENDA

3.1 Follow-up discussion on draft letter to Senator Keiser from the Burien City Council.

Discussion occurred on the draft letter to Senator Keiser thanking her for the \$125,000 in the state budget for a community health impact study and reminding her of Burien Resolution No. 408.

Motion was made to finalize the letter pending minor revisions and bring to Burien City Council for approval at the August 5, 2019 Council meeting. Motion passed unanimously.

3.2 Discuss draft letter to Congresswoman Jayapal regarding questions for FAA.

Discussion occurred on the draft letter to Congresswoman Jayapal. Burien's contracted federal Government Relations Specialist, Mike Doubleday, has been in contact with our federal representatives on these FAA issues. There are new staff in Adam Smith and Jayapal's offices.

Discussion occurred on if the questions being asked in the letter impact the City's lawsuit against the FAA. Burien's City Attorney will review the letter and ensure it is suitable to send.

Motion was made to forward the letter, with minor edits, to the City Attorney and if she is comfortable with it, bring to Burien City Council for approval at the August 5, 2019 Council meeting. Motion passed unanimously.

3.3 Continued discussion on Part 150 concerns and options.

The document prepared by Burien Airport Committee member Sharyn Parker, called "Preface and Summary of Themes in Comparison Matrix (Rev 7/23/19)" was reviewed and

discussed. The opening remarks of the document are a summary and can be used for background information. The Committee decided to extract about a dozen questions from the document to form a letter to the Port of Seattle. Committee member Sharyn Parker will draft the letter to the Port, with Chair Nancy Tosta to review. Discussion occurred on whether the letter should go directly to the Burien City Council or should other cities be asked to sign on/join.

3.4 Continued discussion on SAMP presentation and next steps.

Per request of the cities, their SAMP consultant, Lockridge Grindal, provided observations on if what the Port is saying matches what they are doing. Two major concerns are:

- 1. Growth and impact between 2012 and 2018 are not addressed.
- 2. 3rd runway is being used far more than intended.

Port just approved \$10 million for design of SAMP near term projects, which was not done transparently. Discussion occurred on if Burien should approach other cities to join them in withdrawing from the Sea-Tac Stakeholder Advisory Roundtable (StART) or simply suspend until further notice.

Motion was made to recommend that Burien suspend their participation in StART until further notice. Motion passed unanimously.

3.5 New discussion on joint meeting with the Des Moines Aviation Advisory Committee in September.

Discussion occurred on having a joint meeting with the Des Moines Aviation Advisory Committee at the next meeting on September 17, 2019. An invitation will be extended to them to join the meeting. Potential agenda items for the meeting were discussed.

4.. PUBLIC COMMENT

Public comment on checking with others before suspending participation in StART. There are new Port Commissioners coming in that seem to want to listen.
