### 1. CALL TO ORDER

Mayor Sofia Aragon called the Burien Airport Committee meeting to order at 6:05 p.m.

### 2. ROLL CALL

It was noted that Mayor Sofia Aragon and Committee Member Steve Wydick would be absent and were excused upon a motion made by Committee Member Jeff Harbaugh, seconded by Committee Member Karen Veloria. The motion passed unanimously.

- b) Update on StART (SEA Stakeholder Advisory Round Table) Activities: City Attorney Newsom provided an update from the StART meeting, specifically that the meeting focused on sustainable and alternative jet fuels and questions about where airports could be expanded or built.
- c) **Committee Workplan Review**: There was a brief discussion whether the provided workplan was the most recent iteration. Review of the most recent draft workplan can continue next meeting.
- d) **Federal Legislative Updates**: No updates to provide for this meeting as Mayor Aragon was unable to attend.

### 6. PUBLIC COMMENT

Dave Kaplan, Port of Seattle, provided some additional context regarding the FAA reauthorization letter and encouraged Burien community organizations to apply for South King County Community Impact Fund, the Economic Recovery Grant program and the Environmental Grant program.

### **DEFINITIONS**

<u>Advisory Body Members</u> (<u>City Policy 400-01</u>). Individuals appointed by the Burien City Council and represented through the Planning Commission (PC), Business and Economic Development Partnership (BEDP), Parks and Recreation Advisory Board (P-RAB), Arts Commission, and Human Services Commission (HSC).

<u>Arts Commission</u> (BMC 2.50.010). The Burien city council created the arts commission to provide advice to the city council on arts, culture programs, and projects; initiate or sponsor programs to increase public awareness of and interest in fine and performing arts and cultural activities; obtain private, local, state, and federal funds to promote art projects in Burien; advise the council and Burien staff on obtaining or purchasing artwork for municipal installation; and work with local schools and arts organizations for Burien's benefit.

**Burien Airport Committee** (Resolution No. 405). The Burien city council adopted Resolution No. 384, which created a committee to address the issues related to Seattle Tacoma International Airport.

**Business and Economic Development Partnership** "BEDP" (BMC 2.50.010). The Burien city council created the Burien business and economic development partnership to provide advice to the city council on Burien's economic development through the analysis, consideration, improvement, and review of economic development components of Burien's comprehensive plan, and to make recommendations to the city council on economic development programs and priorities.

<u>Governing Body</u> (<u>RCW 42.30.020</u>). The multimember board, commission, committee, council, or other policy or rule-making body of a public agency, or any committee thereof when the committee acts on behalf of the governing body, conducts hearings, or takes testimony or public comment.

Human Services Commission (BMC 2.50.010). The Burien city council created the human services commission to provide advice to the city council on human services issues in Burien and human services funding allocations by reviewing human services requests and making funding allocation recommendations; to review the performance of Burien-funded human services agencies and programs, and to make recommendations on how human services can be more effectively, cost-efficiently, or better provided in Burien.

**OPMA** (RCW 42.30.090). This chapter [RCW 42.30] may be known and cited as the Washington state open public meetings act or OPMA.

<u>Parks and Recreation Advisory Board</u> "P-RAB" (<u>BMC 2.50.010</u>). The parks and recreation advisory board was created to provide advice to the Burien city council on park-related concerns such as: the use and acquisition of land for parks, trails, and P-RAB facilities; the creation and objectives for P-RAB recreation programs; the identification and pursuit of grants for P-RAB purposes; and the care for trees and other vegetation on parks property.

<u>Planning Commission</u> (<u>BMC 2.50.010</u>). The planning commission was created to advise and make recommendations to the Burien city council on Burien's future growth through analysis, review, and recommendations regarding Burien's comprehensive plan and related land use documents.

### BACKGROUND

Historically, the city's governing body (City Council) and the city's advisory bodies conducted inperson meetings in meeting rooms located at Burien City Hall, Burien Community Center, and Moshier Community Art Center.

Due to the COVID-19 pandemic, which limited public gatherings, the city's governing body and the city's advisory bodies conducted virtual meetings via Zoom Webinar to effectively maintain and conduct business. Currently, advisory bodies continue to conduct their meetings virtually.

With state-of-the-art technology, the City of Burien has paved the way – a leader among neighboring cities – in conducting hybrid (in-person and virtual) city council meetings.

City staff take great pride in creating equal accessibility for city staff, city council, and community members to attend/participate in-person or virtually at city council meetings. Community members can also share comments in-person, virtually, or submit written comments for the record.

### **ISSUE**

On September 8, 2022, Governor Inslee issued an <u>announcement</u> to end the state of emergency by October 31, 2022 (see Proclamation <u>20-05</u>). Because an emergency will no longer be declared, the city must comply with the OPMA by providing a physical meeting location space for community members to attend advisory body meetings.

Conducting an efficient and effective meeting requires resources that staff liaisons must consider when transitioning from a virtual meeting environment to in-person or hybrid meeting environments, such as the following:

### In-person Meetings:

- 1. What meeting room will the meeting be conducted?
- 2. How much time will you need to setup and takedown (e.g., chairs, tables, computer/presentation equipment)?
- 3. Are there hours of limitation for community members to access the building/meeting room?
- 4. How will community members share public comment?
- 5. Is interpretation necessary?
- 6. Are security personnel and elevator access necessary?

### Hybrid Meetings:

In addition to all of the above items, regarding in-person meetings,

- 1. How will the virtual portion be managed/moderated, including public comment?
- 2. Will you need additional staff support?
- 3. What technology or equipment would be required?
- 4. What training would be required?

### RECOMMENDATION

The city has taken great strides to provide hybrid city council meeting access; advisory bodies should strive to meet the city's current business standards (i.e., hybrid meetings). However, in accordance with the OPMA, the priority will be to provide community members a physical meeting location space to attend and participate in-person beginning on November 1, 2022.

With this deadline in mind and the items of consideration listed above, it is recommended that staff liaisons determine how they will conduct their advisory body meetings (in-person or hybrid) going forward with their current staffing/resource levels. The staff liaison shall update their advisory body at their next available meeting.

If conducting an in-person or hybrid meeting is <u>not</u> attainable by November 1, 2022, the staff liaison must produce a written plan documenting what plans and deadlines are in place to comply with the OPMA. The written plan must be filed with the City Clerk by October 31, 2022.

Lastly, it is encouraged for public agencies to make use of remote access tools as fully as practicable to encourage public engagement and better serve their communities (see 2022 c 115 § 1). For this reason, staff liaisons shall report physical and virtual attendance numbers to the City Clerk after each advisory body meeting. The City Clerk will compile the data for review and evaluation with the advisory body staff liaison to determine how best to meet the service levels needed. The City Clerk will provide an attendance form, which is currently being developed, at a later date.




