Water District Reaches Settlement Agreement With Port of Seattle

Highline Water District announces that a favorable settlement agreement has been made with the Port of Seattle regarding the District's water rights and service area. The District has participated in continued negotiations with the Port since September 1998 and was pleased to sign the agreement on November 30, 1999.

Signing of the settlement agreement came after the District's board of Commissioners adopted a resolution during its November 15th regular meeting allowing General Manager Peggy Bosley and the District's legal counsel to proceed and finalize negotiations with the Port.

The settlement agreement comes at a time of intense interest from citizen groups opposed to the third runway. The Water District takes no official position regarding the proposed third runway. The Water District is a Special Purpose District under the laws of the State of Washington and, as such, is obligated to protect its water rights and service areas to insure that its ability to provide clean, safe drinking water to the residents of the District is not compromised. The Settlement Agreement that was reached fulfills these obligations.

"Highline Water District is completely impartial to the 'third runway' debate," said General Manager Bosley. "It does not impact our decision one way or the other." Bosley also stated that the negotiation process has been ongoing for some time and that the settlement agreement is in the absolute best interest for Highline Water District and its customers.

PREPARED FOR THE PURPOSE OF SETTLEMENT DISCUSSIONS PROTECTED FROM DISCLOSURE UNDER ER 408 AND CHAP. 42.17 RCW

SETTLEMENT AGREEMENT BETWEEN THE HIGHLINE WATER DISTRICT AND THE PORT OF SEATTLE CONCERNING TITLE TO WATER RIGHTS AND CERTAIN WATER SERVICE AREAS

Whereas, the Highline Water District is a special district authorized under Chap.57.08 RCW to provide water services to private and public entities within a service area described within its most recently approved Water System Plan. The Port of Seattle is a municipal corporation authorized under Chap. 53.04 and .08 RCW to own, operate and develop airport facilities and to provide water services to its own properties;

Whereas, the District and the Port believe that they each have valid claims to certain water rights shown in Exhibit 1 and referred to in this agreement as Water Right #1 and Water Right #2. Water Right 1 and Water Right 2 may be withdrawn, respectively, from Well #1 and Well #2 which are also shown on Exhibit 2A, #2. B

Whereas, the District wishes to provide water services for certain properties owned by the Port and described more specifically in exhibit _3;

Whereas, the parties wish to resolve their respective claims to Water Rights #1 and #2 and address the future water service needs of certain Port properties;

Whereas, the District's willingness to enter into this agreement should not be construed as support or opposition for the third runway project;

NOW, THEREFORE, in consideration of the terms, conditions, covenants and performance contained in this agreement and its exhibits, the parties agree as follows:

1. *Quiet title* - The parties agree to quiet title in Water Right 1, currently being withdrawn from Well #1, to the Port and to quiet title to Water Right #2, which will be withdrawn from a well that will replace Well #2, to the District. This agreement to quiet title to these water rights is full and final settlement of each party's title claims with respect to each well and/or water right.

2. *Flow augmentation* - The Port may utilize Well #1/Water Right #1 for the purposes of: (a) Des Moines Creek flow augmentation as described in the approved Port's 401 water quality certification for the third runway project and/or the Des Moines Creek Basin Plan; and/or (b) to serve water to the Seattle-Tacoma International Airport property (including future, directly related facilities), pursuant to receiving authorization by the Department of Ecology.

The District may utilize Water Right #2 for any purposes(s) that is authorized by the terms and conditions of said water right and consistent with its own legal authority. The Port agrees to provide all necessary easements for the construction, operation, and maintenance/repair of a replacement well, including the placement of new water lines and electric distribution lines.

3. *Resolution of appeals* - The District agrees to not appeal the Port's application for a 401 water quality certification, Coastal Zone Management Act approval, 404 permit or any other related approval for the third runway project. The District also agrees not to protest, challenge or appeal any proposed change application for Water Right #1 as long as the application is consistent with the limitations of (2) cited above.

4. Water service provider - The Port agrees to utilize the District as its water service provider for certain vacant properties currently owned by the Port and located approximately south of 200th or other areas agreed to by the parties. These properties will be identified and descriptions of these properties will be attached to this agreement as an exhibit.

5. *Highway 509 extension/access roads* - The Port and the Washington State Department of Transportation (DOT) are currently discussing the proposed alignment of the future extension of Highway 509 south of the airport and the proposed alignment of access roads from Port property to the new Highway 509 extension. The access roads on Port property may be located near Wells #1 and #2. In discussing the proposed alignments of Port access roads to the future extension of Highway 509, the Port agrees that it is obligated to protect the District's right of access to and use of Well 2 in the same manner in which it protects the Port's access to and to use of Well No. 1. Further, the Port agrees to not recommend or agree to any access road alignments that in any way impairs, interferes with, or otherwise adversely impacts the Districts right of access to and use of Well #2.

6. *Severability* - If any of the terms or provisions of this agreement are determined to be invalid, such invalid term or provision shall not affect or impair the remainder of the agreement, but such remainder shall remain in full force and effect to the same extent as though the invalid term or provisions were not contained in the agreement.

7. *Governing law* - The agreement and the rights of the parties to this agreement shall be governed and construed in accordance with the laws of the state of Washington.

8. *Authority to enter into agreement* - The District and the Port each warrant that it has the right to enter into this agreement and that the person signing this agreement has authority to bind such person's respective party.

9. *Exhibits* - All exhibits referenced in and attached to this agreement are incorporated within this agreement.






