"hung Yee: I apologize for my oversight on the original distribution of this e-mail. The scope of work that I see remaining on providing acceptable fill criteria language for the drafting of a 401 Water Quality certification would include:

- 1) Review of the previous draft language on clean fill and determine its suitability for the draft 401 Certification
- 2) Response to comments and concerns raised by Pete Kmet on this language
- 3) Review and incorporation into acceptable fill criteria language for the 401 Certification the conditions set on fill quality and placement in the recent Biological Opinion issued by US Fish & Wildlife Service on the Sea-Tac Master Plan Improvements project.

I see your involvement primarily in items 1 & 2, essentially closing out on a project you were involved with during your tenure with NWRO Water Quality relying on your TCP technical expertise.
