Rachel -

Thanks for the write-up. Since I wasn't at the meeting, don't know if I get to comment. A couple items for your consideration,

Page 2, last sentence of 1st paragraph. More accurate if reads "...requirements of the 1998 King County Surface Water Design Manual." You could substitute the word "current" in place of "1998" if you prefer. This provides minor clarification.

Page 3 last bullet. same edit suggested.

Page 3 last bullet. Comment: The grouped checklists were intended to highlight "big ticket" items. Some big ticket items have several components as detailed in the bulk of Enclosure 2. The checklists are only to help group issues for resolution, not to supercede any specific comments. The comments are the comments. If someone wants advise on choosing between focusing on the checklist or the rest of the enclosures, I would strongly suggest focusing on the rest of the enclosures. KCR will prepare a list of items identified in Enclosure #1 and #3 that do not appear in Enclosure #2, if any. KCR will also provide any other level of clarification requested by Ecology.

Page 4 1st sentence. "NRMP comments will be informed by King County comments on the SMP". Not sure I understand what this means. Does it mean Shannon and Wilson have the KCR comments and will consider affect of those comments on NRMP?

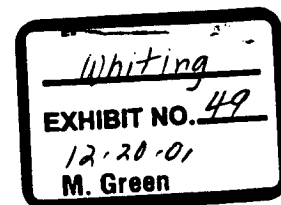
