In the attached letter to me, Eglick refers to an update email from me to Tom L. where he contends I consider the clean fill criteria issue resolved. The email in question includes the following quote by me....

"Clean Fill Criteria -- The WQ Program advises we should use the language from the old 401 with detail added from the procedures provided by Beth Clark. This issue is therefore essentially resolved."

As you can see, I indicated "essentially" resolved. However, on the updated issues list which I attached for Tom L., I indicate we have agreed with the POS on process, but there is no check mark indicating we have approved a clean fill criteria plan. There still is no check mark next to that item. I will not consider the issue "fully" resolved until I hear from Kevin that the plan is final/approved by the WQP in coordination with TCP. At this point, I understand we have a couple of concerns to address before we consider, the issue fully resolved.
