Under state law and regulation [RCW 43.21A.090 and WAC 173-06], the Director of Ecology can delegate signature authority for specific actions to members of his/her staff. Such delegation is conveyed by a letter from the director authorizing the recipient to act for the department with respect to specific functions described in the letter.

The Department maintains a file of all delegation letters, the majority of them dating from 1995 and signed by then-Director Mary Riveland. Through this memorandum, I reaffirm the delegated authorities approved by Ms. Riveland. Ecology staff authorized by letter from the director to carry out duties in the administration of programs and the issuance of orders and directives retain such authority.

Dear Mr. Luster:

This letter formally delegates to you signature authority to issue routine 401 Certifications and/or Coastal Zone Management (CZM) Consistency Determinations. In accordance with WAC 173-06-030, Delegation of Powers, you may carry out the following specific functions of the Permit Coordination Team, Environmental Review and Sediments Section in Central Programs, Department of Ecology. This authority may be exercised under the following statutes:

- * Chapter 90.48 RCW (Water Pollution Control Act)
- * Chapter 90.58 RCW (Shoreline Management Act)

Specifically, you are delegated the authority to:

1. Issue routine, short-term water quality modification administrative orders.
2. Issue routine Section 401 certifications.
3. Respond to federal licenses and NEPA documents on behalf of the state pursuant to the Governor's Executive Order #81-18.
4. Issue consistency determinations under the States Coastal Zone Management Program.


