DELIVERABLE 2 (PINK) FEEDBACK

King County provided the following feedback on the pink D2 submittal, which will be addressed in a yellow D2 submittal targeted for late this week (3/30):

1. Figure B2-3B will be changed to show gauge 42C, consistent with the scoping discussion held 3/14.
2. Inconsistency in Table B2-2 will be corrected.
3. PERLND numbers that are not used in the models will not appear on the tables. This is consistent with the 12/00 SMP submittal.

NOTE: Redline strikeout edit tracking will always be against the 12/00 submittal. There is no need to show edits of edits in this fashion.

4. IRS edits to Table B2-3 will be removed/undone. PERLND 16 value should be 0.10.
5. PERLND 64 value(s) that are used in the modeling will be included on the tables.

DELIVERABLE 5 SCOPING

Deliverable 5 is based primarily on Enclosure 2, Group 5 (Encl. 2 page 30) with the exception of Items 2 and 4, and the addition of Group 2 checklist item 15. Deliverable 5 submittal to Ecology and King County is targeted for 4/9.

Deliverable 5 will consist of: Appendix D supplement, Appendix F text changes, revised Table A-3, and revised Sheet C-40 in Appendix R.

The following list summarizes the SMP revisions to be completed by the Port:

1. Structural feasibility of above ground vaults was previously discussed 3/16 when the technical group scoped Deliverable 3 (see page 2 of the March 16 meeting notes).

A supplement to the HNTB memo of 10/27/00 will be prepared describing above-ground vault structural feasibility. The supplement and the original 10/27/00 memo will be provided to Ecology for inclusion in the SMP Appendix D.

The figure of the SDS7 Vault in Appendix D will be revised and submitted to Ecology and King County as a part of Deliverable 3.

2. See Deliverable 6 description, below.
3. The Port will confirm the correct number and make associated text changes in Appendix F regarding the infiltration feasibility of and infiltration proposed to be used for SDW1B.
4. This item will be scoped 4/2 as a separate deliverable.
5. See Enclosure 2, page 19, item #33 for additional detail regarding what King County is requesting to be done to Table A-3. The Port will evaluate the best way to respond to and depict the information King County and Ecology needs. In general, the table will be revised to include 1) whether the project is included in the SMP or not, 2) when the mitigation facility will be constructed (relative to an arbitrary baseline), and 3) project specific notes regarding project type and construction phasing.
6. See Enclosure 2, page 18 & 19, item #30 for additional information regarding King County's comment. The Port will find the source of the wetvault perception and will evaluate the wetpool volume if necessary.
7. This item will be scoped at the Low Flow Augmentation technical meeting 4/4.
8. See item 6, above.
9. See Group 2 checklist, item 15. Appendix R, Sheet C-40, shows temporary Pond B. A note will be added regarding seepage mitigation.

DELIVERABLE 6 SCOPING

Deliverable 6 will consist of documentation of the feasibility of maintenance of the deeper than standard and above-ground vaults. This documentation will be in the form of a memo and will be submitted to Ecology and King County for inclusion in Appendix D. The memo will address feasibility of the following:

- a. Human access
- b. Equipment access, availability and limitations
- c. Pumping depth and feasibility
- d. Inspections and frequency of maintenance
- e. Sediment removal
