## DELIVERABLE 5 (PINK) KING COUNTY FREDEACK

King County provided preliminary feedback on Deliverable 5 (General). Additional feedback, if any,  $\sim$  ill be provided at the 5/7 meeting.

- The correction made to Table 4-6 is acceptable.
- Text edit to the new note on Page 7-9: the word "conservatively" will be removed.
- A ripple edit to the footnote on Page H-10 is acceptable.
- The Port will make the following revisions to Table A-3:
  - o All "No" responses with the (g) footnote will be changed to a dash with the (g) footnote.
  - o Runway 34R is a retrofit

- For Phase 1 & 2 Taxiway, add the north-draining ponds (SDN3X, SDN2X, SDN4X) in the facility column. Add a footnote regarding phasing.
- Phase 3 (#1) facility column revisions: change SDS7 to SDS3A, and add SDN3A.
- Strike Air Cargo note "Increase...IWS."
- Add a Des Moines Tech Center comment: "Not included in SMP."
- The South Access Connector is both Retrofit and New.
- The Dual Taxiway 34R facility should be SDS4 (not SASA).
- Regarding the Expansion of NEPL to 6000 Stalls: If it is in the modeling, "Yes" should be under Permanent Stormwater Detention Required column. If it is not in the modeling, leave Year MPU in Service and Facility columns blank.
- No changes from the 12/00 SMP submittal are needed for the Phase 1 N.U.T. Parking (Transportation Center) project.
- o SR509 Extension/S. Access: change "No" to a dash.

# DELIVERABLE 6 (YELLOW) KING COUNTY FEEDBACK

Revisions to the Maintenance Feasibility memo are acceptable and no additional review or edits are necessary.

## **DELIVERABLE 3 (YELLOW) KING COUNTY FEEDBACK**

The Port will revise the Deliverable 3 (Des Moines Creek) drawing to show the outfall pipe coming to the lowest contour in order to respond to King County's comment regarding the outfall pipe elevation. The figure will be resubmitted as a green, 3<sup>rd</sup> draft deliverable.

### NEW DELIVERABLE 9: FIGURES

The Port, King County and Ecology agreed to create a Deliverable 9 (Figures) in order to address basin map figure revisions required as a result of King County-requested revisions. All basin map figures will be included in the Deliverable 9 submittal after the remaining revisions in other deliverables are completed.

# DELIVERABLE 7B (154TH STREET) DISCUSSION

Meeting participants discussed the solution proposed by the Port on 4/23/01. It was agreed that the Port would move forward with the following two components:

Remove part of the SDN2X basin that drains to the west and make it a part of MC1.

 Present a table showing impervious area to be removed in the buyout area and the impervious area of the portion of the roadway that is proposed to not drain to the regional facility (MC4) in order to compare impervious area changes.

The Port will also provide point of compliance results for the Des Moines Creek regional facility outlet for King County and Ecology review. Proposals other than removing the existing roadway from predevelopment land uses will be presented and discussed at the 5/7/01 meeting.

### **GOVERNOR'S CERTIFICATION REQUIREMENT #5**

Ecology made recommendations regarding the type and format of materials that would assist an evaluation of compliance with Requirement #5 (re: hydrologic divide and average in-stream flows). The Port will consider these recommendations and prepare materials for Ecology review. A King County decision regarding concurrence with the SMP will not rely on these materials.
