# KING COUNTY FEEDBACK: D7 A & B (YELLOW) "MILLER CREEK"

King County comments regarding the yellow Miller Creek submittal are summarized below.

- Turn off the infiltrated water in Run 2 of the 2006 model; RCHRES 257 OVOL 1 should drain to point of compliance. This correction is not anticipated to change the results of the model.
- The Port will verify total inflows and outflows and pond staging at SOV/18.
- Add combined discharge points of compliance to the Summary of Basic Statistics table for the following facilities: SDN3A, SDW1A, SDW1B, Lake Reba, SR 509 and MCRDF.
- The SDN2X-4X 2006 flow frequency and duration curve inconsistency that was documented in the 6/18/01 notes is due to a partial 1997 water year (show mea event).
- The duration plot at MCRDF will be provided (Figure A-9 and Attachment C, Vol. ii).
