- d) **Public Comment Policy Revisions** – The committee discussed moving public comment to the beginning of the meeting agenda.

Mayor Moore moved to change the public comment period to the beginning of the meeting. Second by Louis Troisi. The motion was approved unanimously.

6. NEW BUSINESS

- a) **Opinion Submission to Seattle Times** – The committee discussed writing an opinion piece or a pro-con article regarding the SAMP SEPA EIS.
