## **Greater Highline Community Parks Board**

The Parks and Recreation Committee of the Highline Community Council, in 1977 recommended that the Council and the Highline Recreation Council join in promoting the formation of a major park in the north clear zone.

The first program in the Sunset Center was a recreation program initiated by the Highline Youth Service Bureau.

In 1979, the Port and King county jointly funded a plan for the Park. The firm of Jongejan, Gerrard and McNeal was chosen to work with the Citizen Advisory Board in development of the comprehensive plan for the north clear zone.

With this Plan as a guide, the Greater Highline Community Park Board was formed to implement it.

The Greater Highline Community Parks Board is a non profit corporation that gives Highline citizens and organizations an opportunity to develop and operate the North Sea Tac Park and Sunset Activity Center.

The North Sea Tac Park is a 50 acre park. These lands are sub leased at \$1.00 per year to groups to create a site for their own recreation use, with the stipulation that they have open membership. Thus far there are three groups using portions of the Park:

Kennedy High School - Cross County Trails BMX Club - Bicycle Motocross Course Equestrian Association - Horse practice Arena and Bridal Trails

The Sunset Activity Center is a \$10 million facility (former Sunset Junior High) leased by King County to the park Board for community use. The Center has 2 Gyms, 1 music room, 4 multipurpose rooms, maintainance rooms, construction shop, a cafeteria, kitchen and offices.

Operating and maintance expenses are being met by user fees.
